**DISCUSSION:** Mr. Sneider commented on Loan #1 to the Town of Janesville. He reminded the board that the Town of Janesville took out a similar loan recently. The City of Janesville has increased the amount the Town of Janesville pays for Fire Protection annually, so the Town is taking out another loan to finance the increase. Loan #2 to the City of Ashland is for financing solar panels for the Ashland Area Development Corporation building.

Board Chair Godlewski shared that she recently did a site visit in Washburn. Carver Harries, the head of the Ashland Area Development Corporation, and a few other people from Ashland came with her to talk about the project, how it was financed and visited the actual solar panels. She believes we will see other communities replicating this model in the next few months.

The Board of Commissioners of Public Lands (BCPL) unanimously approved \$170,000.00 in State Trust Fund Loans to support 2 community projects in Wisconsin.

- 1. Town of Janesville / Rock County / Finance fire protection / \$300,000.00
- 2. City of Ashland / Ashland County / Finance solar panels for AADC building / \$70,000.00
